

RAPID TAG EVAC SCENARIO EXERCISE



INTRODUCTION

If a call requires evacuation, RAPID TAG EVAC can be deployed to the Registration area. Salamander's RAPID TAG EVAC solution provides a quick and accurate method for tagging and tracking all injured and non-injured evacuees.

SCENARIO USING THE RAPID TAG EVAC SOLUTION

The following scenario is designed to be used with a computer installed with the RAPID TAG EVAC software, a tethered scanner that is configured with the software, the RAPID TAG EVAC Quick Start Guide, and the RAPID TAG EVAC User Guide. RAPID TAG EVAC relies on medical reference data that is entered in SalamanderLive™. Make sure your SalamanderLive account administrator has set this up. If not, you may use the training organization defined in the scenario execution. Please note, if using the training organization, you will not be able to view detailed reports in SalamanderLive for this event scenario. To save your printing supplies, set the default printer to print to PDF.

EVENT

The Moosewood Fire and Police Department are dispatched to a bomb threat at a local college.

YOUR ASSIGNMENT

You are stationed at the Registration area and are assigned to check evacuees in using RAPID TAG EVAC.

SCENARIO EXECUTION

Start RAPID TAG EVAC

- Ensure your organization information is entered in correctly. To use the training organization, enter in the following information in the Organization tab:
 - Name: Moosewood Emergency Management
 - Code: MWEM49684
 - Type: Emergency Management Agency
 - County: United States
 - State: Michigan
- Ensure the tethered scanner is configured and connected.
- Ensure RAPID TAG EVAC is synced to SalamanderLive (or COMMAND).
- Ensure PDF is selected as the printer default.

Start a New Event

- Start a new event and name it "Dunn College Bomb Threat - Test".

Get External Data

- It is a best practice that you sync any updated external medical reference data from SalamanderLive to your RAPID TAG EVAC computer. This should be done before checking in evacuees.

Check in Evacuees

- A group of 12 college professors and students are looking to get registered. A few of them have minor abrasions from trying to flee one of the campus buildings.
